

RESOLUTION No. 2022-08-04

AUTHORIZING CITY STAFF TO APPLY FOR A STATE DEPARTMENT OF LOCAL AFFAIRS GRANT FOR WINDOW AND HVAC UPGRADES AT CITY HALL AND THE FIRE HALL

WHEREAS, the City of Fort Morgan has the opportunity to participate in grant funding provided by the Colorado State Department of Local Affairs ("DOLA") to assist the City with upgrades to the windows and HVAC systems at Historic City Hall and at the Fire Hall; and,

WHEREAS, the Fort Morgan City Council supports the City's grant application to assist with these upgrade efforts and to supplement the City's recent budgetary priorities for such upgrades, and the City is eligible for all applicable resources, benefits, representation, monies and/or credits that may be available by the State for these purposes; and,

WHEREAS, the City of Fort Morgan has evaluated the circumstances and concluded that it is able to accept these Colorado state general fund monies if granted; and,

WHEREAS, the City of Fort Morgan intends to apply for a grant with DOLA to assist with the window and HVAC system upgrades planned at City Hall and the Fire Hall.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

- Section 1:** The City Council of the City of Fort Morgan strongly supports the application for a DOLA grant to assist with its plans to upgrade the window and HVAC systems at City Hall and the Fire Hall.
- Section 2:** If the grant is awarded, the City Council of the City of Fort Morgan strongly supports the acceptance of the state funds to facilitate and assist the efforts to upgrade the window and HVAC systems at City Hall and the Fire Hall.
- Section 3:** The City Council of the City of Fort Morgan authorizes the expenditure of funds necessary to meet the terms and obligations of any such Grant awarded.
- Section 4:** If the grant is awarded, the City Council of the City of Fort Morgan hereby authorizes the Mayor to sign the grant agreement with the Colorado State Department of Local Affairs, or its designated entity per the Grant agreement, and any other related documents requiring a signature and/or authorization.

Section 5: This resolution is to be in full force and effect from and after its passage and approval.
