

RESOLUTION NO. 2022-11-01

A RESOLUTION ADJUSTING THE ELECTRIC RATES FOR THE ELECTRIC DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN

WHEREAS, pursuant to Sec. 16-1-50, *Code of the City of Fort Morgan*, “[c]harges for the supply of electric. . . service[s] shall be, from time to time, established by resolution of the City Council”; and,

WHEREAS, the City Council of the City of Fort Morgan, acting as the Board of the Electric Department and System Enterprise, has made the following findings of fact:

1. The most recent adjustment to the City of Fort Morgan’s electric system rates was approved on January 2, 2020. Since that time, the costs of purchased power have changed and the scheduled return of funds in the Deferred Energy Account over a four-year period has been completed.
2. The City Council is in receipt of information, dated October 26, 2022, upon which it bases its decision to now increase electric rates as set forth in the attached Tariff Sheets 15 and 16.
3. The Tariff Sheets proposed represent fair and equitable charges for electric service for the Electric Department and System Enterprise. The proposed Schedule of Rates is in the public interest and should be authorized.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF THE ELECTRIC DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1. Effective January 1, 2023, for all utility bills generated on or after such date, the City hereby adopts the Electric Rates and updated Tariff Sheets (attached hereto as Exhibit A).
