

RESOLUTION NO. 2022-12-01

INCREASING THE WATER RATES FOR THE CITY OF FORT MORGAN, COLORADO

WHEREAS, the continued responsible water development for the City of Fort Morgan is in the best interests of the City; and,

WHEREAS, the projected revenues of the water rates were analyzed in a study completed in 2021 by Raftelis Financial Consultants; and,

WHEREAS, the 2021 rate study projects additional increases in fixed costs per year as well as additional capital improvement projects for the water enterprise; and,

WHEREAS, an increase in the water rates would create additional revenue within the Water Enterprise Fund to allow for future infrastructure improvements, rate stabilization and major expansions that will benefit the customers; and,

WHEREAS, pursuant to Sections 17-5-10 and 18-3-10 of the *Fort Morgan Municipal Code*, all water and wastewater rents, rates and charges payable within the City are to be established by Resolution of the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Section 1. Effective January 1, 2023, for all utility bills generated on or after such date, the City hereby adopts the Water Rates attached hereto as Exhibit A.
