

## RESOLUTION NO. 2022-12-02

### INCREASING THE WASTEWATER RATES FOR THE CITY OF FORT MORGAN, COLORADO

**WHEREAS**, as a wastewater service provider the City is responsible for the expenses associated with a treatment facility, collection systems and a pump station; and,

**WHEREAS**, the projected revenues of the wastewater rates were analyzed in a study completed in 2021 by Raftelis Financial Consultants; and,

**WHEREAS**, the 2021 rate study projects additional increases in fixed costs as well as additional capital improvement projects in the wastewater enterprise; and,

**WHEREAS**, an increase in the wastewater rates would create additional revenue within the Wastewater Enterprise Fund to allow for future infrastructure improvements, rate stabilization and major expansions that will benefit the customers; and,

**WHEREAS**, pursuant to Sections 17-5-10 and 18-3-10 of the *Fort Morgan Municipal Code*, all water and wastewater rents, rates and charges payable within the City are to be established by Resolution of the City Council.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**Section 1.** Effective January 1, 2023, for all utility bills generated on or after such date, the City hereby adopts the Wastewater Rates attached hereto as Exhibit A.


