

## RESOLUTION NO. 2023-03-02

### A RESOLUTION ADJUSTING ELECTRIC RATE CREDIT SCHEDULE NM FOR THE ELECTRIC DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN

**WHEREAS**, pursuant to Sec. 16-1-50, *Code of the City of Fort Morgan*, “charges for the supply of electric. . . service[s] shall be, from time to time, established by resolution of the City Council”; and,

**WHEREAS**, the City Council of the City of Fort Morgan, acting as the Board of the Electric Department and System Enterprise, has made the following findings of fact:

1. The City Council is in receipt of information from the Municipal Energy Agency of Nebraska (MEAN) upon which it bases its decision to adjust electric rates for Rate Credit Schedule NM.
2. The changes proposed represent fair and equitable charges for electric service for the Electric Department and System Enterprise. The proposed adjustment of Rate Credit Schedule NM is a pass-through of cost changes from the City’s wholesale electric supplier, is in the public interest, and should be authorized.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF THE ELECTRIC DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN, COLORADO:**

**SECTION 1.** Effective April 1, 2023, for all utility bills generated on or after such date, the City hereby adopts the updated Tariff Sheet 39 (attached hereto).
