

RESOLUTION NO. 2023-04-01

A RESOLUTION AUTHORIZING THE SIGNING OF A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF FORT MORGAN AND ROTARY CLUB OF FORT MORGAN FOR THE 100 TREES PROJECT

WHEREAS, Rotary Club of Fort Morgan has been a vital part of the community for many years and serves to promote community development, goodwill, and understanding through various projects; and

WHEREAS, the City and Rotary Club of Fort Morgan now wish to enter into an agreement for the Fort Morgan Rotary Club's 100 Trees Project, which aims to improve the quality of life and recreation among Fort Morgan area residents and visitors by planting 100 trees in public locations; and

WHEREAS, the Parties wish to enter into this Memorandum of Understanding ("MOU") to memorialize the Parties' collaborative relationship and understanding, and to clarify the duties of each Party, as well as to set forth all terms and conditions between the Parties;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1. The City hereby authorizes the Mayor to sign the Memorandum of Understanding between the City of Fort Morgan and Rotary Club of Fort Morgan for the 100 Trees Project.

SECTION 2. The City Council authorizes the Mayor to execute all necessary documents associated with the MOU and the 100 Trees Project.
