

## **RESOLUTION NO. 2023-0701**

### **A RESOLUTION UPDATING SIGNATORIES FOR THE OPERATION OF CITY HELD BANK ACCOUNTS**

**WHEREAS**, the City of Fort Morgan maintains bank and investment accounts for the safekeeping of City funds; and,

**WHEREAS**, accounts held by the City require signatories to be designated and authorized from time to time.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE  
CITY OF FORT MORGAN, COLORADO:**

**Section 1.** Banks and Savings and Loan Associations insured by the FDIC, Edward Jones, Member of SIPC, with offices situated in the City of Fort Morgan, Colorado, Colotrust, Colorado Statewide Investment Program, the Colorado Surplus Asset Fund Trust, and PFM Asset Management LLC may be used as the depositories of City funds without discrimination and for investment of the funds of the City from time to time.

**Section 2.** Required signatories on City accounts shall be as follows:

1. The City Manager and City Treasurer shall each have the authority to open new bank accounts in the name of the City of Fort Morgan;
2. The following are the authorized signatures on the City of Fort Morgan bank accounts listed in No. 3 below.
  - a. Mayor                                      Sharol Lyn Deal
  - b. City Manager                                Brent Nation
  - c. City Treasurer                               Kasie Edson
  - d. City Clerk                                    John J. Brennan
  - e. General Acctg. Mgr.                        Chris Bostron
3. The following bank accounts of the City of Fort Morgan require two signatures from the authorized list of signatures in No. 2 above:
  - a. Bank of the West – Perpetual Care passbook account
  - b. FMS Bank – Self-insurance checking account
  - c. FMS Bank – Self-insurance passbook savings account
  - d. Wells Fargo Bank, N.A. – CFM Baker Field
  - e. FMS Bank – City of Fort Morgan Police Magistrate Account
  - f. The Bank of the West – Money Market Account
  - g. The Golden Belt Bank – Health Care Checking and Money Market Account.

4. The Golden Belt Bank – the Police Holiday Charity Savings Account shall require two signatures as specified in the April 2, 1991 resolution titled Law Enforcement: Special Enforcement Fund Account and Police Holiday Charity Savings Account. As specified in that resolution, one signature will represent city management (City Treasurer or City Clerk) and one will represent the police department (Chief of Police or designee).

Signatures allowed from city management include:

The City Treasurer shall be authorized to open special purpose bank accounts and designate authorized signatories on said accounts different from No. 2 above, provided, however, that the signature of the City Treasurer shall be required to make any withdrawals or to close said accounts. These special purpose bank accounts shall be limited to a maximum balance of \$2,500.00 without specific Council authorization.
9. The City Treasurer shall have the sole authority to make investments of City monies (including certificates of deposit and purchases of government bonds) in the name of the City of Fort Morgan, excluding the monies of the police and fire pension funds, as provided by the City Investment Policy

adopted \_\_\_\_\_. The authorized signatories on said investments of City shall be as specified in No. 2 above.

**Section 3.** Banks and Savings and Loan Associations insured by the FDIC, with offices situated in the City of Fort Morgan, Colorado, may be used as the depositories of City Certificates of Deposit without discrimination and for investment of the funds of the City from time to time.

**Section 4.** Required signatories on City Certificates of Deposit shall be as follows:

1. The City Manager and City Treasurer shall each have the authority to open Certificates of Deposit in the name of the City of Fort Morgan;
2. The following are the authorized signatures on the City of Fort Morgan certificates of deposits listed in No. 3 below.
  - a. Mayor Sharol Lyn Deal
  - b. City Treasurer: Kasie Edson
  - c. City Manager Brent Nation
  - d. City Clerk John J. Brennan
3. City of Fort Morgan certificates of deposit are presently held at the following institutions:
  - a. Bank of the West – Perpetual Care Fund (1)
  - b. FMS Bank – Perpetual Care Fund (2)
  - c. Wells Fargo Bank, N.A. – Electric Fund and Sewer Fund (2 total)
  - d. Equitable Savings and Loan - Sewer Fund (1)
  - e. Golden Belt Bank – Self Insurance Fund (1)

**Section 5:** Any one of the following are authorized to access the City's safe deposit box for the purpose of secure offsite storage:


