

## ORDINANCE NO. 1285

### AN ORDINANCE AMENDING THE APPROPRIATION OF MONIES FOR THE FUNDS OF THE CITY OF FORT MORGAN, COLORADO FOR 2022

**UPON AND PURSUANT** to the revised estimate of the probable revenue and expenses submitted to the City Council of the City of Fort Morgan, Colorado, and upon a budget made by said Council, and for the purpose of raising funds to defray all expenses of conducting the business of the government of the City and payment of all liabilities of the City falling due or accruing during the fiscal year ending December 31, 2022; and,

**WHEREAS**, pursuant to the City's independent audit of the 2022 expenditures, adjustments to the 2022 budget are required to ensure compliance with applicable laws and accounting practices; and,

**WHEREAS**, 2022 budget adjustments may be made by ordinance up until the finalization of the 2022 audit.

### THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Of the monies arising from electric, water, gas, sewer, and sanitation charges, taxes, fines, licenses and all other sources of monies of the City of Fort Morgan, the appropriation to the several funds of said City for the purposes of operations, debt service and capital outlays is amended as follows and attached hereto and incorporated herein by reference:
