

ORDINANCE NO. 1286

AN ORDINANCE OF THE CITY OF FORT MORGAN, COLORADO, REPEALING CHAPTER 5, ARTICLE 5 OF THE FORT MORGAN MUNICIPAL CODE REGARDING BICYCLE LICENSES

WHEREAS, the City of Fort Morgan, Colorado (the "City"), is a Colorado home rule municipality, duly organized and existing pursuant to Section 6 of Article XX of the Colorado Constitution; and

WHEREAS, pursuant to C.R.S. § 31-15-401, the City by and through the City Council (the "Council") possesses the authority to adopt laws and ordinances within its police power in furtherance of the public health, safety, and welfare; and

WHEREAS, from time to time, the Council finds it necessary to repeal obsolete city ordinances; and

WHEREAS, the Council has determined that registration of bicycles within the City is no longer a worthy use of City resources.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FORT MORGAN, COLORADO, as follows:

SECTION 1. Findings. The above and foregoing findings are hereby incorporated by this reference as specific findings and determinations of the Council.

SECTION 2. Chapter 5, Article 5 of the Fort Morgan Municipal Code, concerning Bicycle Licensing, is hereby repealed in its entirety.


