

RESOLUTION NO. 2024-02-02

A RESOLUTION APPROVING AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE CITY OF FORT MORGAN POLICE DEPARTMENT AND AUXILIUM RESPONDER, LLC REGARDING A CONTRACT FOR FIRST RESPONDER MENTAL HEALTH PEER TEAM TRAINING AND OVERSIGHT

WHEREAS, the Auxilium Responder, LLC is a Colorado limited liability corporation that works with first responders around the state to help train members to be involved in peer support; and,

WHEREAS, first responders are exposed to many traumatic experiences by the nature of the calls they respond to; and,

WHEREAS, in order to better assist officers in the Fort Morgan Police Department with this concern, it sometimes becomes necessary to work with new providers and access specialized training; and,

WHEREAS, City Staff and the City Attorney have negotiated and finalized the subject Intergovernmental Agreement between the City and Auxilium Responder, LLC; and,

WHEREAS, the City Council desires to enter into the attached Intergovernmental Agreement with Auxilium Responders, LLC, attached hereto as Exhibit A, which is incorporated herein, in order to formalize the agreement with Auxilium Responders, LLC as to peer team training services and oversight provided.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1 The City hereby authorizes the Mayor to sign the Intergovernmental Agreement, attached hereto as Exhibit A.




