

## RESOLUTION NO. 2024-09-01

### A RESOLUTION AUTHORIZING THE CITY MANAGER TO SIGN PAPERWORK ASSOCIATED WITH AVIATION GRANTS FOR THE FORT MORGAN MUNICIPAL AIRPORT

**WHEREAS**, the Fort Morgan Municipal Airport has existed in the City of Fort Morgan since 1933; and,

**WHEREAS**, the City of Fort Morgan (the "City") owns the airport and is therefore responsible for the maintenance and care of all aspects of the airport; and,

**WHEREAS**, the Federal Aviation Administration (the "FAA") along with the Colorado Division of Aeronautics ("CDOT Aeronautical") have grants available to assist with expansion and maintenance of runways and aprons; and,

**WHEREAS**, the City needs to expand the apron near the Fixed-Based Operator office and these grant funds would assist the City in doing so; and,

**WHEREAS**, the City Council finds it desirable and prudent, and in the best interest of the general health, safety, and welfare of its residents to allow the City Manager the ability to sign all paperwork associated with these grants to allow for expedient progress of the grant process.

### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1: The City Council hereby authorizes the City Manager to sign all paperwork associated with aviation grants for apron work at the Fort Morgan Municipal Airport.


