

## **RESOLUTION NO. 2024-09-03**

### **A RESOLUTION AUTHORIZING THE CITY MANAGER TO SIGN DOCUMENTATION ASSOCIATED WITH A COLORADO DEPARTMENT OF LOCAL AFFAIRS (“DOLA”) GRANT FOR PROPOSITION 123 FUNDING TO AID IN FINDING SOLUTIONS TO THE AFFORDABLE HOUSING CRISIS**

**WHEREAS**, housing, and especially workforce housing, is of paramount need to the community and local Morgan County workforce; and,

**WHEREAS**, the City of Fort Morgan (the “City”) has committed to increasing the affordable housing supply by a minimum of 3% per year over three years, in compliance with the requirements of Proposition 123; and,

**WHEREAS**, a Department of Local Affairs capacity grant will provide State of Colorado Proposition 123 funds to aid in finding solutions to the affordable housing crisis; and

**WHEREAS**, the DOLA capacity grant will allow the City to fund consultants to continue to work with the local housing task force which is leading the local efforts toward housing solutions in Morgan County;

**WHEREAS**, the City is committed to continuing to work on solutions to address the lack of housing for the community and County’s workforce; and,

**WHEREAS**, the City Council finds it desirable and prudent, and in the best interest of the general health, safety, and welfare of its residents, to allow the City Manager the ability to sign all paperwork and documentation associated with these DOLA grants to allow for expedient progress of the grant process.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

SECTION 1: The City Council hereby authorizes the City Manager to sign all documentation and paperwork associated with and required for a DOLA grant for State of Colorado Proposition 123 funding to aid in finding solutions to the affordable housing crisis, and fund consultants to continue to work with the local housing task force who is leading the local efforts toward housing solutions in Morgan County.
