

RESOLUTION NO. 2024-10-01

INCREASING THE WASTEWATER RATES, WATER RATES, WATER TAP FEES, AND SEWER TAP FEES FOR THE CITY OF FORT MORGAN, COLORADO

WHEREAS, as a wastewater and water service provider, it is the City of Fort Morgan's (the "City") continued responsibility to establish expenses associated with water development and wastewater management: and,

WHEREAS, the projected revenues of the water and wastewater rates and tap fees were analyzed in a study completed in 2023 by Raftelis Financial Consultants; and,

WHEREAS, the 2023 rate study projects additional increases in fixed costs per year as well as additional capital improvement projects for both the water and wastewater enterprise; and,

WHEREAS, an increase in the water rates and tap fees would create additional revenue within the Water Enterprise Fund to allow for future infrastructure improvements, rate stabilization and major expansions that will benefit the customers; and,

WHEREAS, an increase in the wastewater tap fees would create additional revenue within the Wastewater Enterprise Fund to allow for future infrastructure improvements, rate stabilization and major expansions that will benefit the customers; and,

WHEREAS, pursuant to Sections 17-5-10 and 18-3-10 of the *Fort Morgan Municipal Code*, all water and wastewater rents, rates and charges payable within the City are to be established by Resolution of the City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Section 1. Effective January 1, 2025, for all utility bills generated on or after such date, the City hereby adopts the Water Rates (attached hereto as Exhibit A).

Section 2. Effective January 1, 2025, for all bills generated on or after such date for services provided, the City hereby adopts the Water Plant Investment Fees (attached hereto as Exhibit B).

Section 3. Effective January 1, 2025, for all utility bills generated on or after such date for services provided, the City hereby adopts the Wastewater Rates (attached hereto as Exhibit C).

Section 4. Effective January 1, 2025, for all bills generated on or after such date for services provided, the City hereby adopts the Wastewater Plant Investment Fees

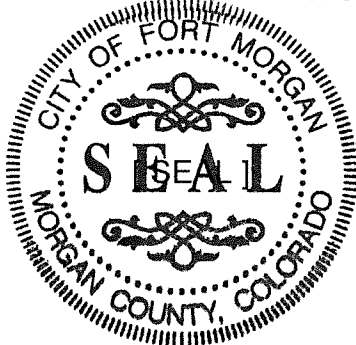





Taps that are used strictly for fire protection systems will be assessed for time and material charges only.

FOR REFERENCE:

The CITY OF FORT MORGAN Municipal Code, Chapter 18, Water System, provides a requirement for the transfer of water rights from Northern Colorado Water Conservancy District's Colorado Big Thompson Project ("CBT") prior to the issuance of a Building Permit. Please refer to the Municipal Code if you have questions about water rights related to a tap. Should a property owner, developer, and/or builder choose to have the City acquire water rights on his or her behalf, the purchase price and service fees are as follows:

WATER RIGHT TRANSFER FEE as set by Council July 2, 2013:

1 EHR (Equivalent Home Requirement) = 144,000 gallons = 1 Unit CBT

Cost per C-BT unit: \$17,500
