

## **RESOLUTION NO. 2025-04-01**

### **A RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO SIGN DOCUMENTATION ASSOCIATED WITH A COLORADO DEPARTMENT OF LOCAL AFFAIRS (“DOLA”) ENERGY AND MINERAL IMPACT ASSISTANCE FUND (“EIAF”) GRANT FOR THE CITY OF FORT MORGAN COMPREHENSIVE PLAN UPDATE**

**WHEREAS**, the City of Fort Morgan (the “City”) Comprehensive Plan was last updated and approved in 2016; and,

**WHEREAS**, it is best planning practice to update comprehensive plans approximately every 10 years; and,

**WHEREAS**, The Comprehensive Plan establishes a basis for future City policies and priorities for development and growth, and provides the City with strategies for economic development; infrastructure upgrades and expansions; and general improvements for community services and character; and,

**WHEREAS**, DOLA supports a community’s effort to have a current comprehensive plan; and,

**WHEREAS**, the DOLA Energy and Mineral Impact Assistance Fund (“EIAF”) grant will allow the City to fund consultants to assist the Planning Commission and staff efforts to work with citizens and other stakeholders to update the plan; and,

**WHEREAS**, the City Council finds it desirable and prudent, and in the best interest of the general health, safety, and welfare of its residents, to allow the Director of Public Works the ability to sign all paperwork and documentation associated with these DOLA grants to allow for expedient progress of the grant process.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

SECTION 1: The City Council hereby authorizes the Director of Public Works to sign all documentation and paperwork associated with and required for a DOLA grant for the City of Fort Morgan Comprehensive Plan Update.
