A RESOLUTION ADJUSTING THE SANITATION RATES FOR THE SANITATION DEPARTMENT OF THE CITY OF FORT MORGAN

WHEREAS, it has been recommended that the Residential rates be adjusted as outlined on Exhibit A; and,

WHEREAS, it has also been recommended that Commercial rates be adjusted as outlined on Exhibit A; and,

WHEREAS, pursuant to Sec. 15-1-140, *Code of the City of Fort Morgan*, "Charges for the collection and removal of garbage and rubbish shall be as from time to time established by resolution of the City Council"; and,

WHEREAS, the effective date shall be as outlined on Exhibit A.

NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1. The Sanitation rates set forth in Exhibit A shall be implemented and in effect for sanitation service billed on or after June 1 of each year.

SECTION 2. The Sanitation rates shall continue in effect thereafter unless or until amended or modified; and further proved that the City Council shall review the utility rates each year.


