

RESOLUTION NO. (2025-07-01)

SUPPORTING AN APPLICATION TO THE COLORADO DEPARTMENT OF LOCAL AFFAIRS (DOLA) FOR THE COLORADO MAIN STREET PROGRAM

WHEREAS, the City of Fort Morgan ("City") is a home rule municipal corporation duly organized and existing under the laws of the State of Colorado; and

WHEREAS, the City of Fort Morgan embraces the four established principals of the Colorado Main Street Program, also known as the Main Street Four Point Approach (Organization, Promotion, Design, Economic Vitality), and with our partner members, will fully utilize the technical assistance and principles to enhance and diversify the City's downtown economic and historic base; and

WHEREAS, the City of Fort Morgan strongly believes it should become a Main Street Community and become part of the Colorado Main Street Program, and intends to continue to commit to the revitalization of the City's downtown through the context of preservation, community self-reliance, local ownership, enhancement, and development of the downtown.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

- Section 1:** The City Council of the City of Fort Morgan supports the application to the Colorado Department of Local Affairs (DOLA) Main Street Program for the purpose of becoming an Aspiring Community and will commit to the revitalization of the City's downtown district through the principles of the Colorado Main Street.
- Section 2:** If the application is approved, the City Council of the City of Fort Morgan authorizes the Mayor' signature of a memorandum of understanding (MOU) with the Department of Local Affairs, and any other related documentation, and agrees to maintain compliance with the requirements of the Main Street Community designation.
- Section 3:** This resolution is to be in full force and effect from and after its passage and approval.


