

RESOLUTION NO. 2025-08-02

A RESOLUTION ADJUSTING THE GAS RATES OF THE NATURAL GAS DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN

WHEREAS, the City of Fort Morgan (the "City") administers the Natural Gas Department and System Enterprise, which serves approximately 4,800 customers;

WHEREAS, the City's natural gas consultant, Raftelis Consulting Group, has recommended that the Residential Service Rate ("Schedule RS") be adjusted by increasing the Supply Charge from \$.3400 to \$.4000;

WHEREAS, Raftelis Consulting Group, has also recommended that the Commercial Service Rate ("Schedule CS") be adjusted by increasing the Supply Charge from \$.3400 to \$.4000;

WHEREAS, Raftelis Consulting Group, has also recommended that the Municipal Service Rate ("Schedule MS") be adjusted by increasing the Supply Charge from \$.3400 to \$.4000;

WHEREAS, pursuant to Section 16-1-50 of the Fort Morgan Municipal Code, charges for the supply of gas service shall be, from time to time, established by resolution of the City Council.

NOW, THEREFORE, BE IT RESOLVED BY BOARD OF THE NATURAL GAS DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1. Effective August 1, 2025, for all utility bills generated on or after such date, the City hereby adopts the Gas Rates attached hereto as Exhibit A.
