

## ORDINANCE NO. 1316

### AN ORDINANCE ADJUSTING ELECTRIC RATES FOR THE ELECTRIC DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN

**WHEREAS**, Article VII, Section 3 of the *Charter of the City of Fort Morgan* gives City Council the “power by ordinance to fix and regulate rates, fares and charges for service by public utility corporations...” and

**WHEREAS**, the costs to the Electric Department and System Enterprise to provide the services in the schedule exceed the current charges; and,

**WHEREAS**, it has been recommended that the Residential, Small Commercial General and Municipal rates be adjusted as follows: that the Consumer Charge be increased from \$9.95 to \$11.95 and that the Energy Charge be increased from \$.0736 to \$.0809; and,

**WHEREAS**, it has also been recommended that Residential Demand Metered, Small Commercial Demand Metered, Large Commercial, Irrigation, Interruptible Load Management Service rates be adjusted as follows: that the Consumer Charge be increased from \$8.17 to \$.977, that the Demand Charge be increased from \$10.22 to \$11.03 and that the Energy Charge be increased from \$.0672 to \$.0745; and,

**WHEREAS**, it has also been recommended that Transmission rate be adjusted as follows: that the Consumer Charge be increased from \$8.17 to \$9.77, that the Demand Charge be decreased from \$10.14 to \$8.50 and that the Energy Charge be increased from \$.0650 to \$.0723; and,

**WHEREAS**, it has also been recommended that Residential Area Lighting and Commercial Area Lighting rates be adjusted as follows: rates be increased from \$7.79 per lamp to \$8.49 per lamp; and,

**WHEREAS**, it has been recommended that Highway Fog Lighting rates be adjusted as follows: rate be increased from \$93.40 per lamp to \$101.81 per lamp; and,

**WHEREAS**, in accordance with C.R.S. § 40-3.5-104 and the City’s adopted tariff sheets, notice of these updated rates was provided by the City at least 30 days prior to a Public Hearing held on the 2nd day of September 2025, at 6:00 p.m. at Historic City Hall located at 110 Main Street, Fort Morgan, CO 80701; and,

**WHEREAS**, the “Fifteen Revised” Sheet No. 15 and 16, attached as **Exhibit A**, shall be incorporated as amended into the published electric rates of the City of Fort Morgan, Colorado, effective October 1, 2025.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE ELECTRIC DEPARTMENT AND SYSTEM ENTERPRISE OF THE CITY OF FORT MORGAN, COLORADO:

**Section 1.** Effective October 1, 2025, for all utility bills generated on or after such date, the Electric Department and System Enterprise of the City of Fort Morgan hereby adopts the "Fifteen Revised" Sheet No. 15 and 16, attached hereto as **Exhibit A**.

**Section 2.** *Severability.* In the event any part of this Ordinance is found to be unenforceable by a Court of competent jurisdiction, it shall not affect the enforceability of the other portions of the Ordinance.



**PAST DUE ACCOUNTS:**
