

## **RESOLUTION NO. 2025-11-02**

### **A RESOLUTION OF THE CITY COUNCIL FOR THE CITY OF FORT MORGAN, COLORADO APPOINTING THE CITY PROSECUTOR AND APPROVING A PROFESSIONAL SERVICES CONTRACT**

**WHEREAS**, Section 2-4-10 of the Fort Morgan Municipal Code (the "Code") establishes a municipal court with jurisdiction to hear, try and determine all causes arising under the Code; and,

**WHEREAS**, the City of Fort Morgan (the "City") contracts for legal services to perform the duties of a municipal prosecutor; and,

**WHEREAS**, the position of municipal prosecutor is currently vacant; and,

**WHEREAS**, the City solicited a Request for Prosecution services in order to fill the vacancy; and,

**WHEREAS**, City staff have selected a candidate for municipal prosecution services and negotiated a contract for legal services; and,

**WHEREAS**, the Fort Morgan City Council desires to appoint Christine Francescani as the Fort Morgan municipal prosecutor and approve the professional services contract.

### **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO, CREATES THE FOLLOWING POLICY FOR THE USE OF PROPOSITION 123 FUNDING:**

**Section 1:** The Fort Morgan City Council incorporates the foregoing recitals as its conclusions, facts, determinations and findings.

**Section 2:** The Fort Morgan City Council hereby appoints Christine Francescani to serve as the Municipal Prosecutor.

**Section 3:** The Legal Representation Agreement, attached hereto as "Exhibit A" which sets forth in detail the terms and conditions of the appointments made by Section 2 above, is hereby approved.

**Section 4:** The appointment made by Section 2 of this Resolution shall become effective on November 4, 2025.
