

ORDINANCE NO. 1117

AN ORDINANCE CREATING AND CONSOLIDATING CITY COMMUNITY SERVICES DEPARTMENTS

WHEREAS, the City of Fort Morgan has undertaken a review of the various needs of the departments within the City organization; and

WHEREAS, the Acting City Manager now recommends the consolidation of six departments into three departments; and

WHEREAS, the consolidation of these departments is in the best interests of furtherance of the City's goals and objectives; and

WHEREAS, the City Charter, at Article V, Section 4(g) establishes the procedure for the consolidation of departments with the recommendation of such consolidation and/or creation from the City Manager and final approval by ordinance from the City Council;

NOW, THEREFORE, LET IT BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

SECTION 1. That the Golf Course and the Golf Maintenance Department are now consolidated into a single Golf Department that shall encompass the same purpose and provide the same services as the two previous individual departments;

SECTION 2. That the Parks Department and the Cemetery are now consolidated into a single Parks Department that shall encompass the same purpose and provide the same services as the two previous individual departments; and

SECTION 3. That the Senior Center and the Recreation Department are now consolidated into a single Recreation Department that shall encompass the same purpose and provide the same services as the two previous individual departments.
