

## **RESOLUTION No. 2011-08-01**

### **A RESOLUTION CALLING FOR A GENERAL MUNICIPAL ELECTION TO BE HELD IN CONJUNCTION WITH THE NOVEMBER 1, 2011 MORGAN COUNTY COORDINATED ELECTION.**

**WHEREAS**, Sec. 2-1-720 of the *Fort Morgan Municipal Code* (2010) authorizes the City Council to determine, by resolution, that any municipal election shall be conducted as part of a coordinated election, from time to time, in accordance with the requirements of and utilizing the procedures contained in the Colorado Uniform Election Code of 1992, and in accordance with an agreement for that purpose between the City and the coordinated election official; and,

**WHEREAS**, the Council may wish to consider placing ballot measures before the voters in November to be held on November 1, 2011, in conjunction with the Morgan County Coordinated Election; and,

**WHEREAS**, the general municipal election to be held on November 1, 2011, will be held on the same day as at least one other political subdivision with boundaries that overlap boundaries of the municipal precincts or which contain the same or some of the same electors, and the eligible electors are all registered electors.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF FORT MORGAN, COLORADO** that:

**SECTION 1:** The general municipal election is hereby called for Tuesday, November 1, 2011, which shall be held in conjunction with the Morgan County Coordinated Election.

**SECTION 2:** The provisions of the Uniform Election Code of 1992 as amended are hereby adopted with respect to the conduct of said election in lieu of the provisions of the Municipal Election Code 1956.

**SECTION 3:** The City Clerk is hereby directed to certify the ballot content for the municipal election to the Morgan County Clerk not later than September 2, 2011.

**SECTION 4:** The Mayor is hereby authorized to enter into an intergovernmental agreement with Morgan County for conduct of the election, pursuant to Section 1-7-116(2) of the Colorado Revised Statutes.
