

## **RESOLUTION NO. 2015-06-08**

### **A RESOLUTION OF THE CITY OF FORT MORGAN, COLORADO, ADOPTING THE 2013 NORTHEAST REGION HAZARD MITIGATION PLAN UPDATE**

**WHEREAS**, the City of Fort Morgan recognizes the threat that natural and manmade hazards pose to people and property within the community; and,

**WHEREAS**, undertaking hazard mitigation actions and planning will reduce the potential for harm to people and property from future hazard occurrences; and,

**WHEREAS**, the City of Fort Morgan, Colorado, with assistance from Bob Wold, has gathered information and prepared the 2013 Northeast Region Hazard Mitigation Plan Update; and

**WHEREAS**, an adopted hazard mitigation plan is required as a condition of future funding for mitigation projects under several FEMA disaster mitigation grant programs; and,

**WHEREAS**, the 2013 Northeast Region Hazard Mitigation Plan Update has been prepared in accordance with FEMA requirements at 44 C.F.R. 201.6; and

**WHEREAS**, the City of Fort Morgan, Colorado, is a local unit of government that has afforded the citizens an opportunity to comment and provide input in the Plan and the actions in the Plan; and

**WHEREAS**, the City Council of the City of Fort Morgan, Colorado, has reviewed the Plan and affirms that the Plan will be updated no less than every five years;

### **NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

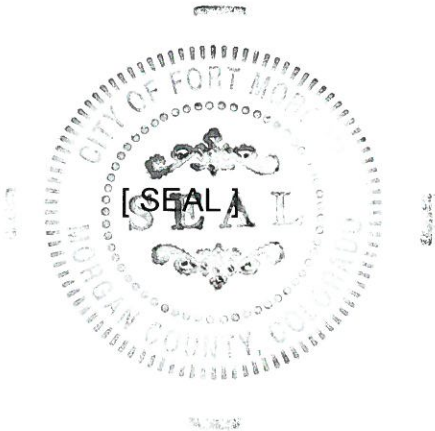
