

## **RESOLUTION NO. 2016-12-03**

### **RESOLUTION AMENDING THE 2017 SCHEDULE OF FEES**

**WHEREAS**, the City of Fort Morgan relies upon fees to provide many services to customers and citizens; and,

**WHEREAS**, fees associated with the services provided by the City require adjustment from time to time to account for the increase in the costs to provide such services; and,

**WHEREAS**, the City Council has adopted the Schedule of Fees as a part of the 2017 budget process on November 1, 2016; and,

**WHEREAS**, since the adoption of the 2017 Schedule of Fees, the Fort Morgan Police Department has determined that a "VIN Inspection Fee" is needed to ensure proper cost recovery for the service provided in an amount of \$15 in order to be consistent with other law enforcement agencies in the county; and,

**WHEREAS**, the Amended 2017 Schedule of Fees is attached hereto and incorporated herein as Exhibit A.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**SECTION 1** This resolution and accompanying Schedule of Fees is intended to supersede all previous fee schedules adopted by the City Council.

**SECTION 2** Effective upon approval, the City hereby adopts the 2017 Schedule of Fees (attached hereto as Exhibit A).

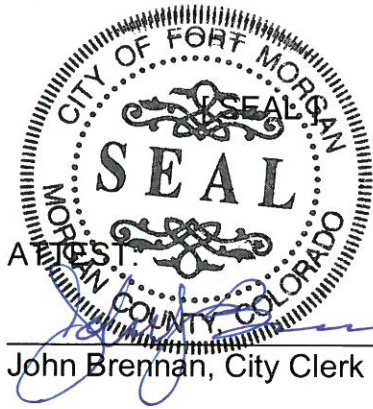
