

## **RESOLUTION NO. 2017-04-03**

### **A RESOLUTION RATIFYING THE EMERGENCY EXPENDITURES FOR AN HVAC SYSTEM AT THE WASTE WATER TREATMENT FACILITY**

**WHEREAS**, the City of Fort Morgan HVAC system at the waste water treatment facility, which was approximately 20 years old, was found to be failing at keeping the facility at the appropriate temperatures; and,

**WHEREAS**, under Chapter 2 Article 8 of the Fort Morgan Municipal Code, the Mayor has authority to declare an emergency for purposes of the emergency management and operations of the City; and,

**WHEREAS**, the procurement policy of the City of Fort Morgan, per Chapter 4 Article 6 Section 50, allows the Mayor to authorize expenditures for emergency purchases; and,

**WHEREAS**, the procurement policy of the City of Fort Morgan requires that any emergency purchases in excess of \$10,000 be ratified by the City Council; and,

**WHEREAS**, due to the safety and welfare implications of losing heat in the waste water treatment facility, the Mayor approved the emergency expenditure to replace the HVAC system; and,

**WHEREAS**, the City has procured the replacement of the HVAC system from Bob Staley's Plumbing, which was completed on March 9, 2017, in the amount of \$20,200.00 which included the HVAC system and installation costs.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:**

**Section 1:** The expenditures to Bob Staley's Plumbing, in the amount of \$20,200.00, for replacement and repair work on the City of Fort Morgan's waste water treatment facility HVAC system, is hereby ratified and made effective by the City Council of the City of Fort Morgan.
