

RESOLUTION No. 2017-10-01

SUPPORTING THE GRANT APPLICATION FOR A MARIJUANA IMPACT GRANT FROM THE COLORADO DEPARTMENT OF LOCAL AFFAIRS

WHEREAS, the City of Fort Morgan has the opportunity to participate in grant funding provided by the Colorado Department of Local Affairs (“DOLA”) as a part of DOLA’s 2017 Marijuana Impact Grants designed to assist local governments who do not allow the sale of retail marijuana within their jurisdiction but who are experiencing the impacts of retail marijuana from other communities; and,

WHEREAS, the City of Fort Morgan supports the DOLA grant application for the expenses, costs, and other impacts incurred as a result of activities related to the sale, transfer, cultivation, or processing of retail marijuana by nearby communities; and,

WHEREAS, the City of Fort Morgan will request funding from DOLA to provide funding for youth education and prevention services related to drug use.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

- Section 1:** The City Council of the City of Fort Morgan strongly supports the application for a grant with the Colorado Department of Local Affairs.
- Section 2:** If the grant is awarded, the City Council of the City of Fort Morgan strongly supports funding youth education and prevention services.
- Section 3:** The City Council of the City of Fort Morgan authorizes the expenditure of funds necessary to meet the terms and obligations of any Grant awarded.
- Section 4:** If the grant is awarded, the City Council of the City of Fort Morgan hereby authorizes the Mayor to sign the grant agreement with the Colorado Department of Local Affairs.
- Section 5:** This resolution to be in full force and effect from and after its passage and approval.
