A RESOLUTION ADOPTING THE FORT MORGAN 2010 COMPREHENSIVE PLAN UPDATE

WHEREAS, the City of Fort Morgan, through the Planning Commission, is empowered pursuant to Section 31-23-201, et. seq., C.R.S. to make and adopt a master or comprehensive plan; and

WHEREAS, the Planning Commission has previously prepared and the City Council has adopted the "Fort Morgan 2003 Comprehensive Plan (the "2003 Plan"); and

WHEREAS, the Planning Commission has caused to be prepared the "Fort Morgan 2010 Comprehensive Plan Update" (the "2010 Plan Update") as an amendment to the 2003 Plan; and

WHEREAS, the 2010 Plan Update complies with the requirements of Section 31-23-201, et. seq., C.R.S.; and

WHEREAS, the Planning Commission conducted a public hearing and subsequently adopted the 2010 Plan Update as in the best interest of the City on September 17; and

WHEREAS, an attested copy of the 2010 Plan Update was certified to the Fort Morgan City Council and the Morgan County Board of County Commissioners pursuant to Section 31-23-208, C.R.S.; and

WHEREAS, the Planning Commission believes that it is in the best interest of the Town that the 2010 Plan Update be adopted and would recommend that it be approved by City Council.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FORT MORGAN, COLORADO:

Sec. 1: The Fort Morgan 2010 Comprehensive Plan Update dated October 5, 2010, is hereby approved.

INTRODUCED, PASSED, APPROVED AND ADOPTED this 5th day of October 2010, the vote upon roll call being as follows:


